**SECOND AND FINAL NOTICE FOR WRIT OF

Dear Registrar of the Guelph Superior Court of Justice,

- "This is not the correct email address for an Urgent Mandamus so I have forwarded this email to 'x' at ontario dot com for immediate review."

No. Not any of that. Nothing. I can see no logical reason why any One would turn a blind eye to ongoing, aggravated harm upon which this Court is the only avenue of recourse for the Trustee and Executor of a Trust, or a Man Acting 'On His Majesty's Service' in his Sui Juris capacity. My Oath to God, the Crown and Canada's People very much includes Calling out criminal State Actors infecting Canada's Courts with their criminal cancer.

SECOND AND FINAL NOTICE OF DEFAULT JUDGMENT FOR HIGH TREASON

before 'Default Judgment, Nihil Dicit' Will be awarded against You and You Will be presumed to be colluding with the Ottawa Courthouse in conspiracy to Obstruct-Sean from delivering an Urgent Notice to a Judicial Authority, Sally A. Gomery.

Her Honour is the only individual with sufficient Jurisdiction to respond to this Order for a Mandamus to compel performance of criminal State Actors in violation of Standing, Statutory Orders. Notice to Agency is Notice to Principal.

I Wish to be perfectly, crystal clear with You. 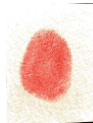
There is no administrative or judicial explain a Sean for Your delay, I can only presume collusion and conspiracy with the Ottawa Courts.

**NOTICE OF DEFAULT JUDGMENT: NIHIL
DICIT, RES JUDICATA**

Dear Guelph and Superior Court Registrar,

You were clearly advised that if You did not confirm receipt of this filing and forward to the appropriate office for assignment and execution that,

1. Ongoing, irrevocable, aggravated harm Will continue to compound against My Beneficiaries,
2. You know that the cause of Act-Sean for this very Urgent Mandamus for an Order is to ***stop the harm being done to Beneficiaries***,
3. As of today, You were Given Notice that failing to take Action has been the cause of futher harassment and abuse of the Beneficiary in violate-Sean of his right to complain to a Court of competent Jurisdiction for Remedy,

8. You were advised that a Man Acting in his Sui Juris capacity in Service of His Majesty is Acting in the capacity of a Governor General to His Majesty in his Sui Juris State of being.
9. You were advised that trespass or obstruct-Sean of a Governor General in Canada comes with a criminal charge of High Treason,

Therefor, You are hereby Noted in

Default Judgment, Nihil Dicit

He is Greater than Me,

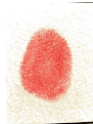

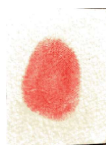
