To the Registrar,

Whereas,

- Trustee may apply to court for directions:

Trustee Act of Alberta

82(1) A trustee may apply to the court for directions ***on any matter or question of fact, law or discretion arising in respect of a trust.***

(2) Without limiting subsection (1), if Trustees ***are deadlocked (obstruction) on any matter arising with respect of a Trust,*** a Trustee may apply to the court for directions respecting ***the resolution of the Matter.***

Section 83 Chapter T-8.1

(3) The duty of a trustee who follows the directions given under subsection (1) or (2) is discharged *with respect to the subject-matter of the directions (jurisdiction)*, unless the Trustee is guilty of fraud, Willful concealment or misrepresentation in obtaining the directions.

(4) ***This section prevails over any contrary provisions in a trust instrument.***

Trustee Act of Ontario

Application of Act

66. Subject to section 67, unless otherwise expressed therein, this Act applies to ***all Trusts whenever created and to all Trustees whenever appointed.*** R.S.O. 1990, c. T.23, s. 66.

Powers, etc. under Act and Trust Instrument

67. ***The powers, rights and immunities*** conferred by this Act are ***in addition to those conferred by the instrument creating the Trust***, and have effect ***subject to the terms thereof.*** R.S.O. 1990, c. T.23, s. 67.

Express Terms of Trust Instrument to Prevail

68. Nothing in this Act authorizes a Trustee to do anything that the Trustee is in express terms forbidden to do (allow for administrative roadblocks by corrupt or incompetent Court clerks in Ontario to allow for aggravated harm to become the Trust's Beneficiaries), or to omit to do anything that the Trustee is in express terms directed to do by the instrument creating the Trust (protect Beneficiaries from the harms of incompetent, criminal clerks of the Ontario Courts). R.S.O. 1990, c. T.23, s. 68.

URGENT APPLICATION TO THE COURT OF KING'S BENCH FOR AN EXTRAORDINARY ORDER OF MANDAMUS AND DECLARATORY RELIEF CONCERNING THE SYSTEMIC SUBVERSION OF JUSTICE IN THE PROVINCE OF ONTARIO

To the Registrar of the Court of King's Bench,

This email is pursuant to Section 82(1) of the Alberta Trustee Act.

As Trustee for the Kingdom of Heaven Found a Sean (an Express Trust on Record with MOJAG Correspondence Unit, January 19th, 2017), I am applying to this Court for directions on the critical Matter of the ongoing ***criminal obstruction of justice, fraud, and contempt*** by the Superior Courts of Justice in Ontario, their agents, and administrators of the Government of Ontario (provincial AG, Doug Downey).

These Actions have caused ***aggravated harm to become My Beneficiaries***, significant loss to the Trust, and constitute a direct threat to the administration of

Justice in Canada and compounding liability upon the Crown and its reputation in Canada.

As per Section 32(1) of the Trustee Act of Alberta, I am seeking the Court's intervention to confer upon me the necessary Power to put an end to this corruption and to enforce the Judgments that have been rendered in default (*nihil dicit*) by [local, provincial] Tribunals (SBT and LTB).

I am filing this Application electronically pursuant to Section 98(2)(c) of the Act, which permits delivery by electronic transmission (email).

You can read about the criminal contempt of the Ontario Superior Courts here - they have clearly been compromised by treasonous State Actors.

Charter Violations

2. Everyone has the following fundamental freedoms:

freedom of thought, belief, opinion and expression, including freedom of the press and other media of communication.

I am also a rights advocate, international journalist read by over 150 countries worldwide, a Key witness in Ottawa's 'Kickback Scheme' and have been targeted and attacked by municipal police services attempting to report these crimes and obstructed by every Court 'guaranteed' to provide Relief and Remedy under 24.1, which is also applicable in Alberta.

Me, and My Beneficiaries require immediate relief and an *Urgent hearing before a Court of **COMPETENT** Jurisdiction* as guaranteed by Canada's Charter under 24.1, Provisions of the Court.

I expect this Application to be accepted and scheduled for an immediate hearing via Zoom.

I hope and Trust the Alberta Courts take Justice and the Crown's repute a Sean more seriously than Ontario does.

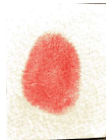
