🛡️ FORMAL LEGAL NOTICE 🛡️

To: Sergeant Catherine Wood, Legal Services, Ottawa Police Service

Sergeant Wood,

This email serves as formal notification that officers from the Ottawa Police Service have just visited My residence in a clear and blatant Act of retaliation for the "Final Notice of Liability" I served upon You and Your department earlier today at 12:27 PM.

The officers arrived, issued a fabricated and legally void "criminal warning for assault," and attempted to intimidate Me into silence. This visit was not an investigation; it was a retaliatory harassment campaign designed to punish Me for holding You accountable for Your misconduct and that of Your department.

This Act is:

Witness Tampering:

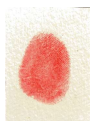
