**NOTICE OF CIVIL AND CRIMINAL LIABILITY:
FRAUD, BREACH OF TRUST, TRESPASS**

Dear LTB Feedback,

To Whom this Present a Sean May be Gifted,

Special Attention to Robert the Belligerent Brown

I am Writing You today to report the systemic fraud and use of the LTB as a laundering facility for washing the theft of subsidies and the intentional gaslighting of serious violate Sean's of the RTA and Canada's Charter, constituting a serious breach of Trust.

In this Way, the LTB and SBT have both served in concert together as the laundering facility for the City of Ottawa's 'Kickback Scheme' reported by the CBC and 'allegedly' under investigation by the Ottawa Police Service since 2024.

I am an international free Lance Journalist, constitutional and international rights Advocate, and have been reporting on this Matter for over six years. You Will find My Domain (Jurisdiction) in the Head of this email.

I am Writing You today to report [the most recent fraud by Robert the Belligerent Brown](#) (the Stage name this State Actor has earned for his Role in Universal Pictures Greatest Present a Sean) who recently fined My Trust, 'The Kingdom of Heaven Found a Sean' \$300.00 for the Pleasure of being gaslit throughout the entire proceeding, pleading ignorance of the Trust it Self and My duties and obligate-Sean's as its Trustee and Executor to ensure that My Beneficiaries receive appropriate represent a Sean before any Judicial Court or Tribunal.

- Whereas the Courts and Tribunals of Ontario are considered to be of **competent** Jurisdiction to hear Charter violate-Sean's under Provisions of the Court, 24.1, and
- Whereas the SBT and LTB have demonstrated gross *incompetence*, pleading 'Willful Blindness' to Trust obligate-Sean's, Charter violate-Sean's, and egregious breaches of the RTA, in violation of their duties and obligations to this Tribunal and Canada's Charter, and
- Whereas Robert the Belligerent Brown
 1. Plead ignorance of every piece of evidence uploaded to the LTB portal in file LTB-T-024798-23
 2. Plead *ignorance* of the Trustee Act of Ontario
 3. Forbid the Trustee from Acting as counsel for his Beneficiary and
 4. Forbid the Trustee from attending the hearings
 5. Threatened and intimidated My Beneficiary, the Tenant appealing to this Tribunal for relief from the egregious maintenance breaches of the slumlord, Multifaitth Housing Initiative (hereby Mafia Hustle Initiative, or MHI)
 6. ignores a doctor's order advising the maintenance delays are causing aggravated psychological and emotional distress to the tenant, depriving her of her Living Sanctuary and the ability to Live in Peace
 7. denied My Beneficiary of all rights to competent legal or lawful counsel in violation of her right to choose her own competent counsel
 8. [Trish the Colluding Carson](#) also perpetrated fraud and copyright violate-Sean by asserting that the REASON for refusing to let the Trustee Act as counsel for his Beneficiary was because [I had 'mocked' LTB adjudicator James William the Complicit Campbell](#), suggesting this was 'inappropriate conduct' while citing My blog Post reporting on his crimes, deliberately *omitting the REASON for mocking James William the Complicit Campbell*, which was for
 9. aiding and abetting the theft of public subsidies by the slumlord MHI,
 10. pleading ignorance of the Trust and the Trustee Act of Ontario in LTB-T-025326-23

11. ignoring the fact that the slumlord MHI has not provided receipts upon request in compliance with the RTA to any of the over 400 tenants subject to their exploit a Sean and abuse
12. the slumlord MHI is now attempting to evict Me in bad Faith under LTB-L-069155-26 in retaliation for escalating these Matters to the Divisional Court for Judicial Review, as the Ottawa Police Service have proven to be complicit
13. Robert the Belligerent Brown then adds insult to injury by fining the tenant \$100.00 for being denied the right to have her evidence and testimony heard
14. denied her right to all counsel
15. and also fined 'The Kingdom of Heaven Found a Sean' \$300.00, stating that neither party can bring any other claims before the LTB until these fines are paid which is
16. economic extort-Sean and exploit a Sean of both Me and My Beneficiary

A Call to the LTB service representative Christina (who was very polite and courteous) made earlier today, told Me that there is no Record of any fine against either the tenant or 'The Kingdom of Heaven Found a Sean' Trust, though she does recognize that the Trust was the One responsible for filing the application to the Tribunal (LTB-T024798).

Christina insisted there is NO RECORD OF THE FINE AGAINST THE BENEFICIARY OR THE TRUST, and that there Will be nothing stopping either My Self or My Beneficiary from bringing a new application before the LTB.

This proves that Robert the Belligerent Brown is engaged in serious fraud and complicit in MHI's money laundering operation. They steal subsidies, the SBT turns a blind eye and if One threatens to appeal the decision to a Divisional Court, You threaten them with fines that don't exist on the LTB Record?

You attempted to threaten and intimidate People for as King for Justice.

And NOW, after I advise I am appealing to the Divisional Court for Judicial Review You accept another application to evict pleading ignorance of the very Trust Robert the Belligerent Brown just fined in LTB-069155-26?!

I Will be including the transcript of My converse a Sean with Christina earlier today and Will publish it along with the Story I am Writing about the LTB's complicity in the City of Ottawa's Kickback Scheme.

I figure if You Wish for feedback and there is any One Honourable overseeing this Tribunal, maybe now is a Good time for damage control because at the moment, the LTB is jointly and severally liable because My Trust is also on Record with MOJAG, and the Courts and Tribunals of each of the provinces and territories are of congruent and

concurrent jurisdiction. This means the right Hand does not have the luxury of pleading ignorance to what the left Hand is doing.

The LTB is currently pleading ignorance (Willful Blindness) of the emails I have sent to the official email address for the LTB, advising that LTB-L-069155-26 is also a violate-Sean of Section 83 of the RTA which states that the slumlord MHI cannot bring a claim to evict in retaliate-Sean for other Matters seeking judicial remedy against the same party (slumlord MHI).

This has further escalated as the Trustee and Executor has also now been assaulted with a weapon by the landlord (scalding hot coffee Sahada the Satanic Alolo threw at the back of My head as I was leaving community coffee on Tuesday, August 25th) in retaliate Sean for My advocacy, appeal before the SBT Tribunal and Application to the Divisional Court for all of Your criminal conduct.

Please, do not misunderstand My email to You. These individuals represent three individuals within the LTB, one of which has already resigned by his own volition. The other two are Trish the Colluding Carson and Robert the Belligerent Brown. Any One endorsing this conduct is also obviously complicit, but I do not presume every One at the LTB is using the Tribunal to launder money and the theft of subsidies by criminal landlords, that has only been My experience to date so far.

Make sure that no evidence from the online portal is spoliated in any Way, as failing to maintain these pristine Records Will be presumed an additional Act of obstruct-Sean.

JUDICIAL NOTICE

You Will also take Judicial Notice of My Sworn Oath of office on Record with MOJAG and His Majesty, Charles III. I am Acting in My Sui Juris capacity as a Governor General to His Majesty, and My job *specifically* is to Call out corrupt State Actors violating their Oath and tarnishing the Crown's repute a Sean.

Criminal Charges must be laid against Robert the Belligerent Brown, James William the Colluding Campbell, and Trish the Colluding Carson.

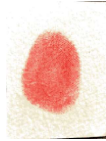
