Dear Professional Standards Advisor, Megan 'The Heroin' Herasimenko,

Thank you for your professional and prompt response regarding My formal notice, file OPS-26-204142.

Please accept My Sincere Gratitude. This email is, without exaggeration, the first legitimate, professional, and service-standards-compliant reply I have received to any of My formal complaints against the Ottawa Police Service in over six years of dealing with systemic misconduct and obstruction.

For that reason, I Wish to formally commend You. In a department where I have been met with silence, procedural gaslighting, and outright retaliation from senior officers like Sergeant Catherine the Wicked Wood, Your adherence to protocol is a beacon of what the Ottawa Police Service should be. It is Genuinely reassuring to know that there are still Honourable members within the Professional Standards Unit who are Willing to acknowledge correspondence and direct it through the proper channels, rather than simply ignoring it or, worse, retaliating against the Messenger.

For clarity, My "Final Notice of Liability" was not a request for a public complaint investigation. It was a formal notification of a multi-million dollar liability claim against specific officers and the department for conspiracy, obstruction of justice, and retaliatory harassment. The retaliatory police visit to my residence yesterday, which occurred shortly after my notice was served, is a prime example of the misconduct I am referring to and Will be filed as evidence.

Futhermore, I believe the entire fabricated incident is in retaliation for the City of Ottawa's legal counsel, Genevieve Langlais going into default in a Matter related to One of My Beneficiaries where she is aiding and abetting the obstruct-Sean of Lawful Orders before both the SBT and LTB, aiding and abetting the City of Ottawa's determine a Sean to withhold OW documents, plead ignorance of Trust documents commissioners of Oaths for their office have Signed, and have stolen over \$5000.00 in Entitled Benefits as part of Ottawa's 'Kickback Scheme'.

Genevieve Langlais has been covering over for criminal state Actors in Willfull obstruct-Sean of lawful Orders for over six years, lying to Me about the Benefits I was Entitled to receive, and aiding and abetting the obstruct-Sean of My Remedy, and that of My Entitled Beneficiaries who have placed their Trust in Me as a result of the City of Ottawa Public Trustee's gross incompetence and failure to put a stop to aggravated harm becoming Beneficiaries. I do not believe any Judge in a Court of Competent Jurisdiction Will believe that the police knocking on My door yesterday attempting to intimidate Me under fraudulent charges for a fourth time in six years is unrelated to the City of Ottawa being noted in default for over 100 million dollars. I don't think any reasonable Judge Acting in Honour Will believe these events are unrelated.

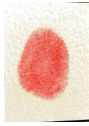
