🔮 FORMAL LEGAL NOTICE 🔮

Dear Megan the Heroin Herasimenko,

I am officially requesting for two warrants to be Issued Immediatel for the arrest of Sonia and George for filing a false police report, bringing violence and chaos to My Door, assaulting Me repeatedly by poking Me in the chest at the end of every sentence, then attempting to frame Me as the aggressor? 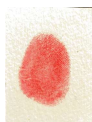
