Good day,

You Will Notice that I have attached the email thread where several Ontario Works agents ignore the Subsidy Renewal Request which Kelly Kritsch approved over the phone including Hydro utilities in the amount of \$60.00 that Will be added to the Beneficiary's basic needs as he is paying the difference not covered by OESP directly. It was determined that if the \$60.00 is excessive any credit balance that accumulates on the account can be taken into consideration at this time next year.

Rental insurance is also covered and I advised Mathieu Regimbald that I Wish to have that set up or receive a credit for the loss of that Benefit to be made whole as the loss of an Entitlement is a form of economic harm.

Furthermore, My lease states that the landlord has the duty to pay any amount not paid by the City of Ottawa, so this email I am receiving is unlawful, illegal and constitutes criminal harassment. The city of Ottawa had a duty and obligation to Keep Me informed of the status of the subsidy and failed to do so. For the fourth time in a row and the entire PURPOSE of sharing the email thread regarding subsidy was to PROVE, IRREFUTABLY that it makes no difference how persistent or diligent I am, they are

actively TRYING TO SABOTAGE THE SUBSIDY!!! This was NOT an administrative error, this is malicious, criminal breach of Trust.

Not only does this demonstrate the impunity with which the City of Ottawa Will engage in fraud to exploit and intimidate Beneficiaries, it demonstrates how little respect any One at Ontario Works has for this Tribunal. All of these criminal breach of Trust perpetrated by State Actors were done so with impunity before this Tribunal, showing that You are complicit.

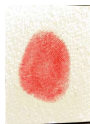
