🏯 FORMAL LEGAL NOTICE 🏯

To the Ottawa Trial Coordinator and the Honourable Court,

I am Writing to request an Urgent Motion for a Writ of Mandamus to stop the compounding aggravated harm being inflicted upon my Beneficiary, Ingrid Windsor Joseph, by the City of Ottawa and its agents.

This request follows an in-person visit to the Ottawa courthouse on Tuesday, August 4th, at approximately 10:04 AM, where I was assisted by a clerk at the civil desk (ticket C408). A transcript of the full encounter can be found here.

I have been attempting to bring Urgent motions before this Court for weeks, only to be met with complete silence from the official Superior Court email address, 'ottawa.scj.courts@ontario.ca', which IS the correct email address as per the Ministry of the Attorney General's (MOJAG) own practice directions for One who requires a Court of COMPETENT and INHERENT Jurisdiction and a hearing before a JUDGE of the

Superior Court of Justice. 'The Superior Courts of each of the provinces are the default Courts of inherent Jurisdiction' - Provisions of the Court, 24.1, REMEDIES.

The clerk at ticket C408 informed me that my emails were not being received and instructed me to send my urgent motion request to this address:
ottawatrialcoordinator@ontario.ca.

This is a deliberate act of obstruction. It is the exact same tactic used by the City of Ottawa's "Kickback Scheme" to launder public funds: using fraudulent or alternative email addresses to direct legitimate filings off the official record, creating the illusion of process while ensuring no action is ever taken.

I am formally requesting the following:

A Forensic Audit:

I demand an immediate forensic audit of the official email address ottawa.scj.courts@ontario.ca to determine the number of My urgent Motion requests that were deliberately ignored or deleted. This audit will expose the full extent of the obstruction charges for which the City of Ottawa and Genevieve Langlais are responsible and liable to Me for.

The Identity of the Clerk:

I demand the name of the clerk who served Me at ticket C408 on Tuesday, August 4th, 10:04 AM. I will be seeking a SUMMONS for their arrest for refusing acceptance of My physical motion and for knowingly directing Me to a fraudulent email address (this one) to aid in the obstruction of Justice.

The Writ of Mandamus:

I demand an immediate Writ of Mandamus compelling the City of Ottawa to cease its harassment, comply with all Lawful Orders and Default Judgments awarded against them by the SBT, LTB, HRT0, and all other administrative bodies, and provide a safe and permanent Living solution for my Beneficiary as it is laid out in the Default Judgment awarded against the City of Ottawa.

The Motive for this obstruction is clear:

Justice Sally A. Gomery, who oversees Matters in this jurisdiction, is awaiting a Motion regarding the City of Ottawa's criminal contempt for the Rules of Civil Procedure in a previous Matter, 21-86803 and the Ottawa Courthouse has been obstructing all My

filings ever since. The system is being manipulated to prevent that Motion from ever being heard.

I am copying this email to the official court address to ensure it cannot be ignored. I am also sending a copy of this correspondence, including the evidence of this clerk-directed fraud, to the Superior Court of Justice in Guelph, where my original documents and Oath are filed.

I am also serving the on Genevieve Langlais as I Promised her that she Will accept full criminally liability for the City of Ottawa as well as civil liability for Actively defending the egregious criminal Acts perpetrated by City of Ottawa staff. Even the City councillors all agree (though some are involved and were clearly social posturing like Good narcissists) described Ottawa's 'Kickback Scheme' as 'disgusting'. The City of Ottawa's liar posing as lawyer has been Actively aiding and abetting the redirection of public subsidies from Entitled Beneficiaries into the Hands of not for profit slumlords across the entire City. All My Beneficiaries are casualties of the City of Ottawa's exploit a Sean and retaliation for appealing to the proper administrative bodies for relief, which only proved to be complicit.

The City of Ottawa has successfully infiltrated the Court's administrative processes to lie, cheat, and steal to Keep the 'Kreling Criminal Cabal' and the 'Ottawa Kickback Schemes' alive and well, turning Canada's nation capital into a laundering facility for white collar crimes and the exploitation of Canada's most marginalized minorities.

Please, it needs to STOP. A-REST Genevieve Langlais allow Canada's People access to Justice in the Ottawa Courthouse once again.

I have also reported this to the local police, attempted reporting to OPP police and the RCMP. There are active file numbers of My reporting but no arrests are being made. The inspectorate of policing, Ryan Teschner has also been made aware of these crimes and determined the Ottawa Kickback Scheme is 'frivolous and vexatious' complaint and not a Matter of public interest.

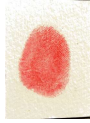

Judicial Notice to Amend Email Service Address for Megan Herasimenko of Ottawa Police Service, correct email address is, 'HerasimenkoMS@ottawapolice.ca'. to which this email is forwarded to.

Active Police Investigation Files for Ottawa's 'Kickback Scheme'
