What happened?

Hello, I am calling to report an active, urgent criminal matter involving municipal negligence, criminal breach of trust, and unlawful entry/privacy violations at an emergency shelter facility in Ottawa, putting a vulnerable adult and a child with severe autism at direct risk. On July 25, 2026, shelter housekeeping staff committed gross negligence by leaving private room doors wide open and placing infested, unsanitary bedding on the beds, allowing an unaccompanied, unsupervised minor child to wander directly into a private sleeping space while an occupant with autism was resting. Staff failed to secure the facility, failed to report the incident, and exposed residents to severe safety and trafficking risks. Furthermore, (add the others instances of fraud and unlawful eviction and Nahas keeping ODSP and human trafficking) we have recorded audio evidence wherein state caseworkers (including Kaitlin Hart) have admitted to wire fraud and unauthorized financial misappropriation of statutory



support funds. Banking assets have been arbitrarily frozen, and administrative agents are acting in bad faith without lawful jurisdiction. We are requesting that the police immediately execute warrants, investigate the facility's gross security failures, take formal statements, and enforce compliance, as the safety of this household is in immediate jeopardy.
