NOTICE OF CLAIM FOR FRAUDULENT CAET

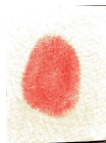
There is no Record of Your appointment which means Your application is a FRAUD.

This email thread Will be used as evidence of Your contempt and tacit conceding to all charges.

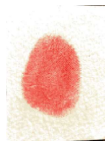
