MHI LEDGER ACCOUNTING DISCREPANCIES

Dear Kelly,

Thank You very much for the receipt, I do appreciate that tremendously - getting the same from My slumlord, MHI is like pulling teeth. This is important because they were found to be engaged in fraud and wrongfully receiving Benefits I was Entitled to. So far, only \$1016.00 of over \$8000.00 in total Entitlements owing to Me have been restored to make Me whole for this egregious wrongdoing.

Most of those Entitlements are NOT owed to Me by the slumlord, MHI, Kelly - those Entitlements are owed to Me specifically by You for Your 'mistake' (Giving You the Benefit of the doubt here).

It is You (Home for Good) that owes Me the equitable Value of the lost Benefits the Beneficiary is *Entitled* to receive by Way of Your own documentation. It is You that failed to communicate to Me and Ontario Works that the utilities and other housing expenses like rental insurance were covered 'ab initio'. You are just as responsible for My not receiving them now as any One else. In fact, I Will dare say You are the principal party in My grievances with the city (and there are many).

I am thing King any One Will agree that to 'make Me whole', You Will need to Give Me the equitable (commercial) Value of the Benefits I was unlawfully deprived. That is what I believe any One Acting in a Trusted position of office Will do if they are Acting in Good Faith, especially after being found to have breached that individual's Trust in the past.

According to Sarah the Liar Lorenz own accounting (which she provided as evidence for the LTB), MHI received \$412.00 in July, leaving \$720.00 unpaid.

This is the first discrepancy because I'm not sure where the extra \$22.00 is coming from? MHI only receives \$390.00 for housing and because \$45.00 of that is paid directly to Hydro by Way of the subsidy (which continued uninterrupted, unlike payments to MHI), only \$345.00 is paid directly to MHI.

Furthermore, what happened to the last month rent deposit? The rent deposit increases in Value by Way of interest equal to the maximum allowable rental increase rate for the year, ensuring the deposit is always equal to the Value of one month rent.

So the correct accounting ledger SHOULD look more like this...

- July - \$1132.00-\$1132.00 (security deposit)=\$0.00
- July- \$345.00 paid direct by OW=\$345.00
- Aug.-\$1132.00-\$345.00= \$-787.00
- Aug. \$-787.00 + \$345.00=\$-442.00
- Sep. \$1132.00+\$442.00=\$-1574.00
- Sep. \$-1574+\$345=\$-1229.00

I need to know what is going on with My rent, please. What happened to the last month deposit and why is the Sarah the Lawless Liar Lorenz as King for \$2406.00 if only

\$1229.00 was owing? If the security deposit has not been spent and is on the ledger, then why was it not applied to the account to prevent it from going into default and providing reasonable time to remedy the situation before filing with the LTB?

Let's presume MHI spent My last month security deposit and the account immediately went into default on July 1st.

- $\$1132.00 - \412.00 (MHI accounting) = $-\$720.00$
- $\$1132.00 + \$720 = \$1852.00 - \$345.00 = -\$1507.00$
- $\$1132.00 + \$1507.00 = -\$2639 + \$345.00 = -\$2294.00$

So even if I rely on MHI's own accounting and what is paid directly by OW (\$345.00), there was only \$2294.00 outstanding, why did You issue a payment for \$2406.00?

This is according to the ledger that MHI provided for the LTB Record. What is the extra \$112.00 for in this scenario?

If We rely on the first set of calculate-Sean's (which is what the accounting ledger should look like if everything is being done correctly and there is no fudging of numbers), the total amount owing Will be \$2361.00 (to pay back the LMR deposit). In this scenario, We have a \$45.00 overpayment to the slumlord.

In their email to Me, Sarah the Lawless Liar Lorenz is claiming there is \$2510.00 outstanding. Sarah the Lawless Liar Lorenz accounting doesn't even match her own from the account ledger provided in July according to the calculations above. How does Sarah the Lawless Liar Lorenz manage to Create the additional \$216.00 and how is that not fraud?

Whose accounting should We rely on and do You Mind Showing You work and how MHI proved their case to You? What You paid is not what the slumlord was as King for. You don't have a problem with the not for profits You subsidize violating the RTA and My right to full disclosure of what they are receiving for rent from the City. And not Sarah the Lawless Liar Lorenz own spreadsheet she drafts composed of fiction, but an actual receipt Showing the bank transaction from the city to the slumlord is what I am lawfully Entitled to under the RTA.
