NOTICE OF FRAUD, HARASSMENT AND BAD FAITH

Dear LTB Registrar,

I have sent several emails to You complaining of the fraud and contempt of the slumlord Applicant, Multifaith Housing Initiative who was found to be stealing utility Entitlements from the Beneficiary in their last unlawful attempt to evict the tenant in violation of the RTA's Rule 84.

I am sick and tired of this Tribunal 'ghosting' My emails, failing to file any of My claims onto the LTB Registry (the Order catalogue) and have witnessed the LTB aid and abet the crimes of slumlord Multifaith Housing Initiative in three consecutive claims, NONE of which are on the LTB Order catalogue - otherwise known as REGISTRY FRAUD.

Please also find the attached receipt of payment from the City of Ottawa's Kelly the Criminal Kritsch confirming a payment to the landlord of \$2406.00.

This Application was Issued in bad Faith and fraud, they have received the rent and continuing with the Application to harass and intimidate the tenant in violation of his rights under the RTA (which You are supposed to be making sure the landlord does NOT violate, not aiding and abetting their determination to do so).

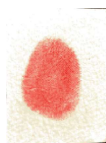

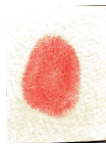

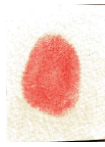

NOTICE OF LIABILITY AND OBLIGATIONS TO THE RTA

Dear Sarah Lorenz,

This email is served upon You in compliance with the Rules and practice direction of the LTB. You have proved by Way of Your email that You are continuing to proceed with this Application despite having received the funds, Promising Me a receipt by Way of regular mail when I have just expressly advised You to send all correspondences to Me by Way of email and on the LTB Record if it concerns receipts because I am NOT interested in any more Word documents You Present to Me Showing half of what You receive without providing RECEIPTS (bank statements and transfers from the City of Ottawa to Your account) in Word and Excel documents You Create to perpetrate Your fraud.

The fact that You have not withdrawn this Application which was filed in violation of RTA 84 which does not allow You to commence an Application when there is already a Matter before another Board or Tribunal (SBT) is already an Act of 'Bad Faith'. The SBT

Matter is under Appeal and the Appeal has been accepted. The Application to the SBT is to recover the subsidy funds You were complicit with the City of Ottawa's Kelly Kritsch in stealing from Me. That is fraud.

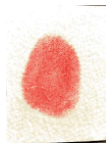
