NOTICE OF DEFAULT JUDGMENT, NIHIL DICIT, RES JUDICATA

Attention Elizabeth the Colluding Kirby,

You are hereby Noted in

Default Judgment, Nihil Dicit, Res Judicata

in Your personal, private capacity for Breach of Trust and High Treason for using Canada's Courts as a cloak for fraud and pleading Willful Blindness to the criminal Acts of the Ontario Works Administrator.

The following evidence was provided which You are pleading 'Willful Blindness' to in Order to make the above decision:

1. Entitlement Forms for subsidies from Home for Good dating back to 2020-2021 through 2025-2026, proving the Beneficiary has been in receipt of Entitlements for utilities and home expenses *by Home for Good specifically **since at least 2020!!!***
2. Caroline Forget **fraudulently** claims in her submissions that the Beneficiary has only been Entitled to the subsidies since 2023. You **cannot** support the fraud without pleading Willful blindness of the evidence before You.
3. Trust Instrument
4. Trust Declaration

5. A three Way email conversation thread with OW caseworker, Mathieu Regimbald, his supervisor, Lili Mukalay. The Beneficiary *is required to Give Notice of the annual Entitlement forms from Home for Good to Ontario Works so they can process the subsidy and the housing entitlements from the housing portion of Ontario Works Benefits.*
6. There is no Way to plead ignorance to these facts because the explicit instructions for the Beneficiary to send the renewal form to Ontario Works to PROCESS the subsidy is explicitly expressed in the Entitlement Forms themselves (that are on Record as evidence to support this appeal).
7. Bears witness to new threats to evict the Beneficiary by the landlord because the City of Ottawa did not process the subsidy, so it was revoked in retaliation for complaining to the SBT about them doing this to him last year as well!
8. Also bears witness to an N4 Notice to evict and to file with the LTB if payment of the subsidy (that didn't get restored because OW failed to PROCESS the renewal form) is not restored by TODAY'S DATE!?
9. You are NOT making an ORDER to process the subsidy so that the Beneficiary is not unlawfully evicted for no fault of his own?!
10. You have nothing to say about Caroline Forget redacting all of her submissions and perpetrating perjury on the Record, falsely stating the Beneficiary has only been in receipt of subsidy since November 2023? That is enabling fraud on the SBT Record.
11. You have NOTHING TO SAY about Lili Mukalay REFUSING to produce the receipt of basic needs benefits paid out that You Yourself ORDERED her to produce and allowed twenty additional days for her to do so? Now You pretend that didn't happen? You are aiding and abetting obstruct-Sean of Justice and access to My remedy
12. You are violating My rights by pleading ignorance of the Trustee Act of Ontario and pretending it doesn't apply to Me or the Trust I have on Record.
13. This is why I Call You Elizabeth *the Colluding* Kirby because now You are *forcing My Hand.*

NOTICE OF APPLICATION TO THE DIVISIONAL COURT FOR IMMEDIATE, URGENT JUDICIAL REVIEW

These are just some of the grounds for My Application to the Divisional Court, the primary CAUSE OF ACTION and URGENCY FOR THE APPLICATION is because I

have no Idea how I am going to get My subsidy restored as You are enabling the criminal conspiracy to evict Me!

That's why I believe You are complicit in the City of Ottawa's Kickback Scheme because evil persists when Good People do nothing. You have 'NOTHING TO SAY' about the criminal trespasses upon My Trust or their attempt to evict Me in retaliate-Sean? Only a morally bankrupt individual Will try to plead ignorance to the breaches of Trust You were a first Hand witness to as Adjudicator for this Tribunal. Madeleine Mbuyi is no better.

You are hereby served in accordance with Principles integral to Justice in a Common Law Jurisdiction.

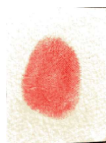
